ORDINANCE AMENDING ARTICLE 4 STOPPING, STANDING, PARKING PROHIBITED, SECTION 102- 482 PROHIBITED IN SPECIFIED PLACES, NO SIGN REQUIRED CODE OF ORDINANCES OF THE CITY OF OXFORD, MISSISSIPPI

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF OXFORD, MISSISSIPPI AS FOLLOWS:

SECTION I. That Article XV, Section 102-482 Prohibited in specified places, no sign required, Code of Ordinances, Oxford, Mississippi, is hereby amended to read as follows:

Sec. 102-482 Prohibited in specified places, no sign required

No person shall stop, stand or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with law or the directions of a police officer or traffic control device, in any of the following places:

- (1) On a sidewalk;
- (2) In front of a public or private driveway;
- (3) Within an intersection;
- (4) Within ten feet of a fire hydrant;
- (5) On a crosswalk;
- (6) Within 20 feet of a crosswalk at an intersection:
- (7) Within 30 feet upon the approach to any flashing beacon, stop sign or traffic control signal located at the side of the roadway;
- (8) Between a safety zone and the adjacent curb or within 30 feet of points on the curb immediately opposite the ends of a safety zone, unless the traffic engineer indicates a different length by signs or markings;
- (9) Within 15 feet of the nearest rail of a railroad crossing;
- (10) Within 20 feet of the driveway entrance to any fire station and on the side of a street opposite the entrance to any fire station within 75 feet of said entrance when properly signposted;
- (11) Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;

- (12) On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
- (13) Upon any bridge or other elevated structure, upon a highway or within a highway tunnel;
- (14) Within 20 feet from the intersection of curblines, or if none, then within 15 feet of the intersection of property lines at an intersection except at alleyways;
- (15) Within 20 feet in front of the entrance of any theater or public building during any meeting or public gathering therein except when taking on or discharging passengers or freight and then not to exceed ten minutes;
- (16) At any place where official signs prohibit stopping.
- (17) On any dedicated bike lane.

SECTION III. REPEALING CLAUSE

All ordinances or parts of ordinances in conflict herein shall be, and the same are hereby repealed.

SECTION IV. EFFECTIVE DATE

All ordinances shall take effect and be in force as provided by law.
